Analysis of the Dilemma and Countermeasures of Social Organizations Participating in Community Elderly Care Services from the Perspective of Collaborative Governance

Abstract

This study takes the perspective of collaborative governance as the theoretical framework to explore the dilemma and countermeasures of social organizations participating in community elderly care services. The research focuses on the role positioning, practice status, dilemmas and solutions of social organizations in community elderly care services. 5. Conclusions and Prospects

However, there are still certain limitations in this study. Future research directions can be carried out from the following aspects: such as deepening cross-regional comparative research, exploring the differences and commonalities of social organizations in different regions participating in community elderly care services, and providing more targeted suggestions for policy formulation; Strengthen long-term follow-up research, explore the long-term effects and sustainability of social organizations participating in community elderly care services, and provide empirical support for policy adjustment. In addition, innovative models of collaborative governance in community elderly care services, such as digital technology empowerment and smart elderly care, can be further explored, and the intelligent and efficient development of community elderly care services can be promoted. From the perspective of collaborative governance, this study systematically discusses the dilemmas and countermeasures of social organizations participating in community elderly care services, and provides theoretical support and practical reference for promoting the sustainable development of community elderly care services. Future research should further deepen theoretical exploration and practical innovation, promote the diversification, specialization and sustainable development of community elderly care services, and contribute to the construction of a harmonious, efficient and sustainable community governance system.
